NOTICE OF ANNUAL GENERAL MEETING

The Annual General Meeting (AGM) of members of the Ontario Beekeepers' Association will take place Friday, November 16th, 2018 at the Best Western Lamplighter Inn & Conference Centre in London, Ontario, as part of the OBA's Fall Conference. The meeting will begin at 1:15 pm.

CALL FOR BOARD NOMINATIONS

Your association is led by a Board of 14 dedicated and hard-working volunteers.

It is critically important to the beekeeping industry in Ontario that your Board represents a diversity of experiences and opinions and that we advocate vigilantly on your behalf to ensure the sustainability of the beekeeping industry in this province. Each year we seek nominations for Board positions – **please consider submitting a nomination or standing for election yourself**. This is an excellent opportunity to develop leadership skills and give back to an exciting, evolving and vibrant community.

As of 2014, the OBA implemented a multi-year approach to Board terms allowing for better continuity and succession-planning. Generally, Board positions are for 3-year terms, however, circumstances creating a vacancy could result in a shorter term. **This year there are five Board positions to be filled**, four with 3-year terms and one with a 1-year term. In addition, a provisional position may be elected, that member to be brought onto the Board should a position become vacant during the year.

Board composition requires at least nine of the 14 Directors to represent the commercial apiary industry.

SUBMITTING A NOMINATION OR STANDING FOR ELECTION YOURSELF



The OBA Board welcomes and appreciates members who can contribute time, expertise and interest in the well-being of beekeeping across Ontario by **submitting a nomination** (either for another member or yourself) **by Friday, November 2, 2018 at 5 p.m.**, two weeks prior to the 2018 Annual General Meeting. Nominees are asked to submit a photograph and short biography to the OBA office as soon as possible.

The biography and photo you submit will be posted on the OBA website and published at the AGM to allow voting members the opportunity to get to know the candidates, their experiences and their perspectives prior to the election.



Candidates will be offered an opportunity to briefly speak to members, summarizing relevant experience and why they would like to serve on the OBA Board.

The election takes place by secret ballot, after which time, the ballots are counted and results announced.

A short meeting of the new Board normally takes place onsite, after conclusion of the AGM, to allow for the election of Officers to take place.

EXPECTATIONS OF OBA BOARD MEMBERS

Those who are nominated and agree to stand for election as a Board member are expected to:

- be a member in good standing of the OBA (or become a member soon after their election)
- embrace and adhere to the [OBA Code of Conduct Policy](#) and [Conflict of Interest Policy](#)
- prepare for and regularly attend Board and committee meetings and help carry out the business of the Board (there are usually four in-person, all day Board meetings per year (January, March, October, November) plus additional Board and committee meetings via teleconference, as needed)
- help the Board meet its fiduciary responsibilities overseeing the OBA
- actively contribute to and stand behind the process and outcome of Board decision-making
- avoid conflicts of interest, and where such conflicts exist, declare them appropriately, and
- recognize and honour the need for confidentiality.

PRESENTING A RESOLUTION AT THE AGM

A *Resolution* is a written motion that is presented to members for discussion and adoption at a meeting of members. Your resolution must be relevant, well thought out, and substantive, and presented in a concise and business-like manner. Traditionally, the OBA calls for Resolutions prior to the Annual General Meeting. **For the purpose of the 2018 Annual General Meeting, Resolutions are due to the OBA office by Friday November 2, 2018 at 5 p.m.** The substance of the Resolution can be anything that is normally presented as a motion; the structure is quite formal. Resolutions require both a mover and a seconder.

As an example, the following Resolution was presented and adopted at the 2014 Annual General Meeting.

RESOLUTION 2

Whereas the Bees Act states that a hive needs to be located 30 metres* from the property line and;

Whereas more and more people are keeping bees in an urban area, not meeting this requirement and;

Whereas honey bees are in decline and it is beneficial to have more diversity in honey bee habitat

BE IT RESOLVED that the OBA approach the government to have this requirement changed/removed to support urban beekeeping.

*Location of hives 19. (1) No person shall place hives or leave hives containing bees within 30 metres of a property line separating the land on which the hives are placed or left from land occupied as a dwelling or used for a community center, public park or other place of public assembly or recreation. 2002, c. 17, Sched. F, Table.

**Proposed Bylaw Change for Discussion and Decision at
OBA 2018 Annual General Meeting**

CURRENT	PROPOSED	RATIONALE
<p>14) Notice of the time and place of holding an annual meeting, special meeting or other meeting of the Association shall be given to each member by special notice by mail at least seven days in advance of the meeting.</p>	<p>Time and Place of Annual General Meeting, General Meeting or Special Meeting</p> <p>Notice of location and time of a meeting of the Association shall be provided to members at least 14 days in advance of the meeting.</p>	<p>An increase in the notice period from seven to 14 days is reasonable and is in the members' best interests.</p> <p>In addition, a 14-day period brings the notice period into alignment with the requirements of the Agricultural and Horticultural Organizations Act, R.S.O. 1990, Chapter A.9, under which the OBA is incorporated.</p> <p>Removing the specific reference to "by mail," permits the OBA to communicate directly with members who have provided email addresses and by mail to those without. Currently, 95% of members provide an email address.</p> <p>When the OBA was made up of a few hundred members, mailing was not an onerous or cost-prohibitive activity. Now at 1400 members (and growing!), mailing to all members is not practical or financially prudent. It appears to be the usual practice of many associations and charities to provide notice to members via email.</p> <p>Additionally, the current situation with rolling strikes at Canada Post has prompted review of this requirement.</p> <p>Going Forward:</p> <p>Current OBA Bylaws require a thorough review to bring them into alignment with current not-for-profit association best practices and legislation, including the Agricultural and Horticultural Organizations Act, R.S.O. 1990, Chapter A.9, under which the OBA is incorporated.</p> <p>In 2019, your Board will conduct a thorough review of the current Bylaws and propose changes to members, which will be debated and voted on at a meeting of members.</p>
